The Los Angeles City Mayor is elected by and accountable to the People of Los Angeles however the Planning Commission is not and therefore they are beholden to the Mayor and not the people of Los Angeles.

The board of the Los Angeles City Planning Commission is composed of nine (9) citizens appointed by the Mayor and accountable only to the Mayor and not the citizens of the city. The Los Angeles City Planning Commission is responsible for recommending approval and rejection of new development projects across the City as well as weighing in on Community Plan updates and zoning changes, and they should represent the voice of the people. However, meeting after meeting, after public comment after public comment, they do not heed that voice.

Every citizen of the City of Los Angeles is impacted by the Planning Commission's decisions and should have a say on who is on the commission to make sure those decisions are equitable for everyone.

In this way, we can have a City Hall more in line with the principles of democracy by divesting power currently held by the city's executive office.

THEREFORE I move the RVNC take a position of SUPPORT for the LA City Council to bring forward a motion, and to pass such motion, instructing the LA City Attorney to return, within 30 days of the passage of the motion, with a proposed amendment to the Los Angeles City Charter for the ballot in 2022 to make the members of the Los Angeles Planning Commission board elected positions and as elected by the citizens of Los Angeles.
